- The Nlets Board of Directors further defined the Brodie Assistance Fund (BAF) guidelines for XML Standardization projects
- The Nlets WAN upgrade project to move to the AVPN solution was completed
- Nlets scaled NOVA, the Nlets Secure Cloud Platform, and added additional services

Additional 2018 highlights:

- The Training Department produced additional multi-media training resources and held its first online webinar
- Ms. Georgene Ramming was inducted into the Nlets Hall of Fame
- Nlets hosted its 51st Annual Business
   Meeting in Lake Tahoe, Nevada, and
   the Implementers Workshop in Tempe,
   Arizona
- Efforts began to reach out to other "Five Eyes" countries, Australia and New Zealand, to further our international outreach








# **Transactions by Year**





#### Nlets continues to build on its financial stability by continued growth and adding a new revenue stream in 2018.


With this financial stability, we are able to invest in the most talented people, some of the best technology, and enhanced security, reliability and expanded capabilities. 2018 saw revenue growth of 19% over prior year, with corresponding expenses only increasing 5%, resulting in improved operating margin of 21.7%. Nlets invested over \$2 million in technology infrastructure, including hardware and security updates at both our main facility and disaster recovery site. Capital outlay continued in 2018 for the NJIN 2.0 rewrite project, which is expected to complete in 2019. \$218K was reinvested back in the membership community through our Brodie Assistance Fund, while continuing to make progress towards the goal of making this a self-sustaining fund. The balance sheet for Nlets is strong as we have secured liquid cash reserves for unexpected needs, zero long-term debt, and minimal short-term operating liabilities. Nlets recently officially closed the books on another solid financial year with the completion of our annual external audit. Audit results were favorable, Nlets received an unmodified (or "clean") opinion, with no material weaknesses in internal controls and no best practice suggestions offered from the auditors.



offerings continue to grow, it is crucial that the Nlets Message Switch continues to operate in a highly reliable manner. Through different system metrics, that the writes into the Nlets Justice Information Nlets technical team monitors regularly, we have seen an upward trend that indicates the current NJIN environment is nearing capacity. Over the last few years, increases in demand have been met with additional hardware. Unfortunately, the current architecture does not provide for infinite additions to the hardware and therefore we must transition to a new architecture to support current and future requirements. With that in mind, Nlets senior management approved and prioritized the NJIN 2.0 Implementation effort. This project is a subsequent effort to the previously completed NJIN Code Review and NJIN 2.0 Design projects.

As use of the Nlets system and our service Nlets began support of these technologies in 2005 with the implementation of the XML Message Router (XMR), which evolved through on-going code re-Network (NJIN). The NJIN 2.0 represents a dramatic deviation from the earlier system implementations and will provide a complete and true Service Oriented Architecture with the ability to scale easily and infinitely. The NJIN 2.0 architecture will also deliver increased stability and availability and provide for improved monitoring and debugging capabilities.

Nlets NJIN 2.0 is the third generation XML and web services oriented Nlets message switch.



# AVPN WAN Upgrade



The WAN Upgrade project was approved by Nlets management and began in February 2018. This project entailed migrating the Nlets private network from AT&T's MPLS PNT offering to their MPLS AVPN service. The AVPN network is a newer technology that allows Nlets the capability of providing a truly any-to-any connectivity solution rather than the point-to-point capability available on the previous PNT network.

Rather than continuing to move forward with an antiquated solution, Nlets staff, with the blessing of the Technical Operations Committee, chose to be more proactive in our migration to the latest technologies and completed the effort in October 2018. As part of this migration to AVPN, Nlets also brought the WIN circuits, which we currently manage, into the Nlets private cloud.

#### **New Record Types Available via NAQ**

In NICB's continued support law of enforcement's efforts to investigate vehicle theft and vehicle crimes, NICB is excited to announce the addition of two record types to the NICB's NAQ Message Key; the NICB Lien record and the NICB Key Code record.

The NICB Lien record indicates that a finance company that is an Associate Member of NICB has an interest in a VIN. The Lien record will return a match containing the name of the lienholder that has an active lien on record with NICB.

The NICB Key Code record will return a match in which a key code and/or an immobilizer reset has been requested of the vehicle manufacturer, by a registered locksmith (Non-OEM) or dealer service center (OEM). The NICB Key Code Record match will contain the date of occurrence, OEM type (OEM or Non-OEM), and a transaction type. The 3 transaction types are: Key Code Request, Immobilizer Reset Request, or Key Code and Immobilizer Reset Request. Non-OEM transactions will also contain a Transaction ID number and a Locksmith ID number.

### **Sunsetting Initiatives**

Nlets is in the midst of a nationwide initiative to sunset legacy technology and adopt more modern, unified standards. Below are the relevant sunsetting motions passed by the Nlets Board of Directors

**BOD Fall 2014 Motion 7** 

Resolve that Nlets will sunset dot delimited text formats by December 2018 at which time all Nlets message traffic will be in standardized XML format.

**BOD Fall 2014 Motion 8** 

Resolved that Nlets will sunset Nlets Socket Protocol by July 2017.

**BOD Fall 2015 Motion 20** 

Resolve that Nlets extend the deadline to sunset dot-delimited text to December 2019.


#### **XML Standardization: Board of Directors Update**

In 2018, Nlets Board of Directors unanimously passed the following motion:

The Brodie Assistance Fund (BAF) Committee recommends to the Board of Directors, that applications requesting BAF dollars to convert dot delimited to XML/NIEM in support of the Nlets sunsetting motion only be approved if that request is for a plan that fully tags each data element and has been approved by Nlets technical staff.

# Charge Code Database



Nlets recently announced the release of a charge code database, available via two new Nlets transactions: Charge Code Query (CCQ) and Charge Code Response (CCR). This query allows a user to enter in a state statute code for any state or territory and receive a response with the corresponding NCIC offense code.

The newly created database was created in support of the U.S. Immigration and Customs Enforcement (ICE) LENS program and is now available to all Nlets users.






